Within the Numbers Financial statement analysis goes beyond simply reading the numbers it involves calculating ratios to understand relationships between different accounts These ratios provide insights into profitability liquidity solvency and efficiency

**A Profitability Ratios** These ratios assess a companys ability to generate profit Examples include Gross Profit Margin Revenue Cost of Goods Sold Revenue Net Profit Margin Net Income Revenue Return on Equity ROE Net Income Shareholder Equity

**B Liquidity Ratios** These measure a companys ability to meet its shortterm obligations Examples include Current Ratio Current Assets Current Liabilities Quick Ratio Current Assets Inventory Current Liabilities

**C Solvency Ratios** These assess a companys ability to meet its longterm obligations Examples include DebttoEquity Ratio Total Debt Shareholder Equity Times Interest Earned Earnings Before Interest and Taxes EBIT Interest Expense

**III Valuation Techniques Putting it all Together** Once youve analyzed the financial statements you can apply various valuation techniques These methods aim to estimate a companys intrinsic value

**3 A Discounted Cash Flow DCF Analysis** This is a widely used method that projects future cash flows and discounts them back to their present value using a discount rate that reflects the riskiness of the investment

**B Relative Valuation** This method compares a companys valuation multiples eg Priceto Earnings ratio PricetoBook ratio to those of comparable companies in the same industry

**C AssetBased Valuation** This method values a company based on the net asset value of its assets Its often used for companies with predominantly tangible assets
